- All manikins include lungs. Does not include one-way-valves.
- AED Trainers come with training pads, a case and batteries. Replacement pads will be charged to the renter at a rate of \$50 per set per set if damaged.
- All electronic items use rechargeable batteries, and should be charged by us prior to rental.
   Should batteries need to be changed do not dispose of the rechargeables. Batteries not returned are subject to a \$5 replacement fee per battery. Batterie Costs are not covered by Silver State Rescue.
- Once signed, renter assumes all responsibility for the above rented items until returned. In the
  event equipment is not returned or it is returned damaged, renter will be responsible for all costs
  associated with replacement or repair.
- Equipment not returned by the date agreed upon will be given a 48 hour grace period. After that time, if no notice has been given to Silver State Rescue, the equipment will be considered missing and a police report will be filed with the Reno Police Department listing the renter as the last known holder of the equipment. Every effort will be made to contact you prior to filing a report. All costs associated with this process will be charged to the renter.
